Entries must be postmarked by February 20, or received by February 23.

MEET SIZE CAP: The meet will be FULL at 700 swimmers. All entries received by the regular entry deadline will be accepted. LATE ENTRIES will be accepted only if the meet is not full.
LATE ENTRIES: If you miss the entry deadline above, you may submit an entry form for events on March 23-25, with an additional \$16 late entry penalty. Late entries must be received by 6pm, Saturday, March 17. Late entries may not enter the 1650 or 1000 freestyle. Late entries received after March 17 will not be accepted. Late entries *must* include a valid 2007 USMS ID
